

**NARRATIVE:** The undersigned has probable cause to believe the above-named defendant on the 17 of February 2017 at 19:44 at 5 AUTUMN BREEZE WY (Zone: 24) in Orange County did

On February 17, 2017 at approximately 7:45 PM, the Orange County Sheriff's Office received a call about a silver Chevy Cobalt driving erratically and the driver screaming unusual noises and barking out the window loudly while driving in the Winter Park Commons Apartment complex located at 5 Autumn Breeze in Winter Park Florida. Several units arrived and attempted to locate vehicle due to a possible incident of excited delirium. Immediately upon arrival, we were able to observe a female in all black clothing near the entrance of the complex. She was identified as Erika Schmitt by other deputies on scene. She appeared to be under the influence of an unknown substance so Orange County Fire Rescue (OCFR) was called to check on her. They said she had no medical issues and she was released by OCFR. We then continued looking for the Chevy Cobalt. While doing so, I was flagged down by the security guard for the complex, Eric Silverstien, who advised the vehicle may have been heading for an exit to the rear of the complex. While speaking with Eric, deputies advised the vehicle was just to the rear of us and approaching our location. I turned my vehicle around along with other deputies and I was able to observe a silver four door car approaching us that matched the description provided by Eric. The vehicle made an abrupt stop and a white male who was later identified as Christopher Lung climbed from the driver's seat out the front driver's window. He immediately sat down near the vehicle. While doing this Eric was sweating profusely and seemed to also be under the influence of some sort of narcotic. Christopher was very jittery and was speaking very loudly. Based on the observations, deputies detained Eric in handcuffs for his own safety along with theirs and the several residents outside. Eric was then looked over by OCFR also. While this was happening, I was able to observe in plain view a small plastic clear bag on the inside driver door panel which contained a brown powder like substance. I believed the brown substance to be heroin based on my training and experience. I collected the bag based on it being in plain view and conducted a field test for the presence of Heroin. I used an agency issued test kit which yielded a presumptive positive result for the presence of heroin. Christopher was then placed under arrest for possession of heroin. I then obtained a sworn written statement from Eric as to what he witnessed prior to our arrival. His statement says the following: Eric said at approximately 7:40 PM he was doing his lock up procedures for the back pool of the complex. He said he was stopped by a resident and informed of their neighbors "acting crazy and yelling". Eric walked over and observed a white male (Christopher) and white female (Erika) in a silver Chevy cobalt yelling at each other. He said he constantly saw Erika enter and exit the vehicle and run around the parking lot. He said the vehicle left the original location and went near building five. He followed the vehicle on foot and observed it driving. He said the vehicle continued driving "erratically, weaving through the parking lot", which made Eric concerned of them possibly crashing. He said the vehicle finally stopped near apartment 48 in building five where Christopher and Erika continued screaming and making loud grunting noises. He said he called the Orange County Sheriff's Office (OCSO) because he was concerned for the safety of Christopher and Erika as well as the growing number of residents outside watching the vehicle. Eric provided OCSO with Florida license plate of H089QB. He said Erika then exited the vehicle again still yelling and ran around the building out of site. He finished his statement by saying he was talking with deputies when he too observed the vehicle approaching. It should be noted the vehicle in which Christopher climbed out of was silver Chevy cobalt which was registered to him and had a matching tag to the one provided by Eric. The suspected heroin weighed approximately .3 grams and was submitted as evidence in the case. Several deputies were wearing body worn camera's, as was I, and they were recording. Eric was transported to the Booking and Release Center without incident.
