On July 11, 2020, at approximately 2314 hours, I responded to 31 Davids Lane Apt. 305. My response was in reference to a disturbance that had occurred. Upon my arrival, I met with Edwin Morales, identified by his FL ID card, who advised me of the the following:

Edwin stated he had been listening to music on his phone when he received a text message from a female friend. He said that his girlfriend, Desiree England, saw him texting the female and asked who the female was. He told Desiree that it was one of his friends and that the female was asking about Edwin's son. Edwin advised Desiree then proceeded to push him off the chair he was sitting on and then hit him on the arm. Edwin attempted to get away but Desiree grabbed on to his shirt, ripped it, and proceeded to punched him in the face. Edwin advised he attempted to get Desiree off him, which had caused red markings on her neck. He advised that once he was able to leave the apartment, he called 911.

While speaking to Edwin, I observed a bruise near his left eye and the collar of his shirt was ripped. Edwin advised Desiree was still inside the apartment.

I then made contact with Desiree, identified by her FL driver license. Desiree advised me of the following:

She stated that she had seen Edwin texting a female, which caused her to get angry. Desiree advised she pushed Edwin off a chair and then punched him. She then advised Edwin had followed her and grabbed her, hitting her in the arm and face, causing markings on her neck, arm and face. Desiree advised that this has happened in the past but that she has never called the police.

After my investigation, it was determined Desiree England was the primary aggressor, violating F.S.S. 784.03 (1)(a)(1) Battery-Touch or Strike (Domestic Violence) when she pushed and punched Edwin Morales against his will. This is domestic violence because Desiree and Edwin reside together as a couple and have been dating for approximately one year.

I then placed Desiree into custody. She was placed into handcuffs, checked for proper fit and double locked for safety. I searched Desiree for contraband, which met with negative results. I then placed Desiree in the right rear passenger seat of Ofc. Holcomb's fully marked patrol vehicle and seat belted her. Desiree was transported to Seminole County Jail for booking without incident.
