

**NARRATIVE:** The undersigned has probable cause to believe the above-named defendant on the 24 of May 2018 at 16:45 at 1051 LEE RD #32D (Zone: 14) in Orange County did

On May 24, 2018, at approximately 1657 hours, I, Deputy Sheriff Saad responded to 1051 Lee Road #32D in reference to a battery domestic violence. Upon my arrival contact was made with Kristin Crawford (victim) who advised the following: On May 24, 2018, at approximately 1645 hours, Kristin had been on the phone with her mom advising her of a verbal argument between Edwin Morales (defendant) and herself. While on the phone Kristin stated Edwin attempted to grab the phone from her and attempted to prevent Kristin to communicate with her mother. Kristin advised Edwin could not secure the phone from her hand, so he grabbed her in a "bear hug" around the shoulders, in an attempt to secure Kristin and the phone. Kristin advised the touching was against her will and she attempted to get Edwin off of her using verbal commands. Kristin stated Edwin finally got off of her when she threatened and said she would call the police. Kristin refused to provide me with a sworn written statement but informed me of the incident verbally. My body worn camera was activated during questioning. Kristin refused medical treatment and advised she was not injured. A scratch on Kristin's neck was witnessed, but Kristin advised it was done un-intentionally while she was scratching her neck with her nails. Kristin also advised she did not want to prosecute criminally, but stated she would be willing to testify in court. It should be noted that Kristin stated she is approximately two months pregnant with Edwin's child. A victim rights packet containing a victim's rights pamphlet, confidentiality paperwork, and an orange county sheriff's office business card containing the case number was provided to the victim. Contact was made with Edwin but he refused to provide me with a sworn written statement. Edwin advised nothing had happened between Kristin and his self. Edwin was secured and placed in the rear of my patrol car. Edwin was Mirandized by myself and stated he would be willing to talk without the presence of an attorney. When asked if he was aware Kristin was pregnant, Edwin stated he had found out on the evening of May 23, 2018, approximately one day prior to the incident. Edwin continued to state he had done nothing wrong, and there was no physical altercation between Kristin and his self. It should be noted that Edwin had been arrested under Battery Domestic Violence charges on May 16, 2018 (see orange county case number 18-44991). Based on reports made on scene, as well as my investigation, Edwin Morales intentionally touched the victim against her will. In committing the battery, the defendant intentionally or knowingly touched the victim against her will, and the defendant knew the victim was pregnant with his child. The victim is a household member of the defendant due to the fact that they are presently residing together as if a family, are parents of a child in common and are currently residing in the same single dwelling unit. Edwin was transported to the Booking and receiving center without further incident.
