On 8/26/2013, at approximately 1845 hours, I responded to the Walmart Supercenter located at 1601 Rinehart Road, in Sanford, reference shoplifting. Upon arrival I made contact with Mr. Donta Harper, a Walmart Asset Protection Associate. Present in the office was also a black female, who identified herself as Jonella Barnes.

Harper stated that at approximately 1825 hours, he observed a female, later identified as Jonella B. Barnes, walking fast and looking around her surroundings, in the ladies wear section. Harper stated he observed Barnes select several items of clothing and jewelry. Harper stated he saw Barnes head towards the garden center, where she placed the selected items into her handbag. Harper stated Barnes proceeded to walk towards the front of the garden center, past all points of sale, and exited the premises of the store without attempting to pay for the selected merchandise. Harper stated he approached Barnes, identified himself as an Asset Protection associate, and escorted her to the Asset Protection office. Harper stated Barnes admitted to stealing the property. Harper valued the stolen property at \$61.76, for which he provided a receipt. The receipt will be entered into evidence as DP-1. Harper also provided a printed photograph detailing the stolen property. This photograph will be entered into evidence as DP-2.

Upon making contact with Mrs. Barnes, I read her Miranda Rights from my Miranda Warning card. Barnes stated she understood her rights, and that she wished to speak to me. Barnes stated she came to Walmart with the intent to steal property, with the intent of selling it later, in order to obtain cash for her rent. Barnes stated she was advised by a friend to steal from Walmart and sell the goods for cash. Barnes refused to identify that friend.

Barnes was placed in handcuff restraints, which were double locked and checked for proper fit. Barnes turned over all of her property to her girlfriend, Richea Hampton, who arrived on scene subsequently. The stolen property was recovered by Donta Harper. Barnes was transported to the Seminole County Jail without incident, and turned over to jail deputies for processing.

Statements made by defendant prior to, during, and after arrest as related to each charge:

The defendant, Jonella B. Barnes, stated she did steal the property, with the intent of selling it, in order to obtain cash for rent.
