On October 11, 2020, at approximately 2207 hours, as I was conducting traffic enforcement in the area of 20th St & Mellonville Ave, Sanford, I observed a Silver Jeep Patriot, bearing FL tag Z094SX, operating with defective equipment.

I then conducted a traffic stop near Mellonville Ave & 24th St. Upon making contact with the driver, who was identified through his FL DL as Leandre S. Wootson (Arrestee), advised me that he didn't have his drivers license on him, but he was working on getting it back.

An FCIC/NCIC query on Wootson yielded an active warrant out of Lake County, for failure to Appear, case #(18CT005947). In addition, Sanford Dispatch advised me that Wootson driving privileges are canceled for failure to pay traffic fines. Wootson then stated that his driving license was suspended due to unpaid traffic fines, but he has been paying them as he can.

Wootson admitted knowledge of his license being suspended. Probable cause has been established for FSS 322.34, Driving with Suspended License. Wootson was issued the following Traffic warning: WA36610SF (Defective Equipment violation) and ADZ5FUE (DWLS).

Wootson was placed in department issued handcuffs, which were checked for proper fit and double locked. I then transported Wootson to the JEPCE without incident.

My Axon Camera was utilized for the duration of this call.
