

On November 23, 2018, **Leandre Wootson** violated FSS 843.025 Deprive means of communication with law enforcement- domestic violence and FSS 784.03 (1) (A) (1) Battery touch or strike- domestic violence.

Specifically, On November 23, 2018, at approximately 0110 hours, Seminole County Sheriff's Office deputies responded to 4136 Geranium Ln, Sanford, Seminole County regarding a family disturbance. The caller, Tory Davis, informed dispatch of a physical disturbance and that the subject, Leandre Wootson, was leaving the scene possibly heading to Eustis, Florida.

Deputy Sheriff T. Kinkopf canvassed the area and made contact with Leandre Wootson at CR 46A and International Parkway.

Upon arrival, I made contact with Davis. Davis explained the following in a verbal and sworn written statement:

On November 23, 2018, at approximately 0030 hours, she was attending a family gathering at the listed address. At this time her brother, Leandre Wootson (defendant), agreed to give Davis and her son, Reishee Ephron (Juve), a ride to Davis's residence. While gathering her belongings, a verbal altercation ensued. The verbal altercation escalated and turned physical. Davis said the defendant exited the residence then returned enraged. The defendant forcefully and intentionally shoved Davis with both hands throwing her down onto the floor. The defendant repeatedly and forcefully punched Davis about the face area. Family members within the residence attempted to separate the defendant from Davis. Davis continued to gather her belongings to leave. Davis explained she went outside looking for her son and observed him within the defendant's vehicle. The defendant and his girlfriend drove away a short distance while Davis screamed for him to stop. The vehicle came to stop and her son exited the vehicle. The defendant then exited the front passenger seat and again forcefully shoved Davis onto the ground. It should be noted that Davis was landline with the Seminole County Communications Center calling for law enforcement help. The defendant again punched Davis about the face area. Davis explained that the defendant knew she was on the phone calling the police. At this time, the defendant aggressively snatched the phone out of her

hand. Davis said the defendant was yelling at her to "get the fuck off the phone". The defendant was actively attempting to destroy her phone. Davis explained she used her second cell phone to call the police. The defendant dropped the phone and returned into the vehicle and left the scene with his girlfriend. Davis sustained injuries to her face/head and nose. Davis refused medical services. Davis signed the statement of prosecution.

The defendant stated that he was defending himself and denied starting the altercation.

Based on the listed events, the defendant was found to be the primary aggressor. The defendant did not have permission to touch or strike Davis. The defendant also interrupted Davis's emergency call to law enforcement personnel. Davis and the defendant are biological brother and sister thus making this domestic violence in nature.

D/S Kinkopf handcuffed the defendant and transported him to the JEPFC for processing.

I assisted Davis with the domestic violence paperwork. Davis was provided with her legal rights and remedies, victim's pamphlet, and notice of appointment with the State Attorney's Office.
