On October 11, 2017, I conducted a traffic stop on a blue Chevrolet Cobalt for traveling 61 mph in a 45 mph zone in Seminole County. I made contact with the driver who identified herself as Maricruz Trejo. Upon requesting Maricruz for her driver's license, vehicle registration and insurance card, she stated "my license is suspended." I asked her for her vehicle registration and insurance card and she stated she did not have them. I asked Maricruz to step out of her vehicle and she complied.

While checking with dispatch to see if Maricruz has any warrants, dispatch advised me that Maricruz driver's license is currently suspended for failing to pay traffic fines. Dispatch also advised me that her tag was expired and the D.H.S.M.V issued a seize tag order on the tag if the driver is the owner or co-owner of the vehicle. Maricruz is the owner of the vehicle she was operating. I researched Maricruz information on D.A.V.I.D which revealed her license was suspended on 9/22/2016 and she has one prior for driving on a suspended license.

I advised Maricruz that she was being placed under arrest for driving on a suspended driver's license. I secured her in handcuff's which were double locked and checked for proper fit and I placed her in the rear seat of my patrol vehicle.

D/S Moon and D/S T. Johnson shortly arrived on scene and began inventorying the vehicle for towing purposes. During the process, they found two marijuana cigarettes (roaches) with green leafy substances inside the vehicle. A presumptive field test was conducted on the green leafy substance and tested positive for THC which is the psychoactive chemical found in marijuana.

Based on the facts and circumstances of this incident, I found that Maricruz knowingly and intentionally violated F.S.S 322.34 2b - Drive While Lic Susp 2nd Off when she knowingly operated a motor vehicle with a suspended license, F.S.S 893.13 6b - Marijuana Possess Not More Than 20 Grams and F.S.S 893.147 1 - for the two marijuana cigarettes (roaches) found inside her vehicle. I transported
