On August 6, 2023, at approximately 1834 hours, I responded to Burlington's store located at 1301 WP Ball Blvd in Sanford, Seminole County, Florida in reference to a road rage incident.

Upon arrival contact was made with [REDACTED] (victim). [REDACTED] stated that she had just been involved in a physical altercation after a road rage incident in the parking lot with another female, later identified as Tara Bordas (arrestee).

[REDACTED] explained that she had entered into the shopping plaza from Towne Center Blvd and was traveling east in front of the Target store located at 1201 WP Ball Blvd. [REDACTED] advised that there are several STOP signs placed in front of the store for traffic due to the high volume of pedestrians crossing. [REDACTED] advised that she stopped at all the stop signs and for pedestrians crossing, however while she was stopped for pedestrian traffic the car directly behind her driven by Bordas began honking its horn at her. [REDACTED] stated that once the roadway was clear of pedestrians, she continued through. [REDACTED] stated that Bordas then passed her, driving around her, 'flicking her off'. Bordas then parked in front of Burlington's in the first parking space available. [REDACTED] followed and stopped her vehicle behind her and rolled her driver's side window down. [REDACTED] then confronted Bordas advising her that there was high pedestrian traffic and that she did not appreciate her honking. Bordas told [REDACTED] that she had room and could have gone past the pedestrians that were crossing. Bordas approached [REDACTED]'s vehicle while yelling obscenities at her. [REDACTED] then stated that Bordas bent over placing her full face and upper body into her window, entering the threshold of her vehicle while continuing to curse at [REDACTED]. [REDACTED] told Bordas to get out of her vehicle however Bordas refused. [REDACTED] stated that she attempted to put her window up however could not due to Bordas' face inside of the vehicle through the window. [REDACTED] placed her hand up as a barrier between her and Bordas and then attempted to push Bordas out of her vehicle. Bordas then began punching [REDACTED] through the window striking her in the face. [REDACTED] advised that at one point, Bordas even threw her own cell phone and wallet at [REDACTED] and had half of her entire body through [REDACTED]'s driver's side window as she continued to pull her hair and scratch at her face. [REDACTED] advised that she did fight back and cried out for Bordas to stop however she did not. [REDACTED] also advised that Bordas' mother was also present and stood by while the physical altercation occurred. [REDACTED] stated that once Bordas stopped the physical onslaught on her and removed her body from [REDACTED]'s window, [REDACTED] then drove away to distance herself. [REDACTED] also took her cell phone out and captured a picture of Bordas, her mother and her vehicle information prior to leaving. [REDACTED] then contacted law enforcement. [REDACTED] completed a sworn written statement advising that she does wish to pursue charges.

I observed [REDACTED] to have injury to her left nostril, which was documented, and photographs were added to this report. [REDACTED] refused medical attention at this time.

I made contact with the manager of Burlington's who advised that the business did have a surveillance system however it does not capture the parking lot area for the business.

Officer Pacheco of the Sanford Police Department requested that Lake Mary Police respond to 254 Broadmoor Road to make contact with Tara Bordas, the registered owner. Upon notification by Lake Mary Police that they had made contact with Bordas, Officer Pacheco conducted a show-up with [REDACTED] to 254 Broadmoor Road. Officer Pacheco advised that [REDACTED] did indicate a positive identification that Bordas was the same person who had just battered her.

I made contact with Bordas. Bordas was provided her Miranda rights which she acknowledged that she understood. Bordas advised that she did honk her horn at [REDACTED] who was stopped in the roadway however stated that there was no pedestrian traffic and noticed [REDACTED] not paying attention to roadway and was utilizing her cell phone. Bordas advised that afterwards, [REDACTED] did confront her in the parking lot when Bordas was exiting her vehicle. Bordas stated that she had calmly walked up to [REDACTED]'s driver's side window, which was down, and did not have any ill intentions to fight with [REDACTED]. Bordas stated that she told [REDACTED] to step out of the vehicle. When asked why she wanted [REDACTED] to step out of her vehicle, Bordas stated that she wanted to speak with her outside of her vehicle, not to fight. Bordas explained that while she spoke with [REDACTED], her face was in close proximity to the window however never entered the threshold of the vehicle or fully entered [REDACTED]'s vehicle at all. Bordas advised that during their verbal altercation, [REDACTED] then pushed her face backwards initiating the physical altercation. Bordas stated that she did not call law enforcement to report the incident because she wasn't injured and did not see [REDACTED] injured however claimed that she was looking for a non-emergency number to contact law enforcement when Lake Mary Police then arrived at her residence.

Lake Mary Police made contact with Bordas' mother who advised that there was no physical altercation and that she observed the entire interaction from the interior of their vehicle. Lake Mary Police advised that her mother advised that at no point did she exit their vehicle which according to the photograph taken by [REDACTED], she wasn't inside the vehicle and was in fact outside of the vehicle.

After speaking with the involved parties, it is my belief that Bordas is the primary aggressor of the physical altercation.

Due to Bordas, having been found to reach inside [REDACTED]'s driver's side window to commit a battery against [REDACTED], in which [REDACTED] has been found to have sustained injury, probable cause has been found for Burglary With Battery.

Bordas was arrested on the above charge. Officer Pacheco transported Bordas to the Seminole County Jail for further processing without incident.
